## **BY-LAW NUMBER 7718**

A BY-LAW TO ESTABLISH A LOCAL ARCHITECTURAL CONSERVATION ADVISORY COMMITTEE KNOWN AS 'CITY OF WELLAND HERITAGE ADVISORY COMMITTEE' AND TO PROVIDE FOR THE APPOINTMENT OF MEMBERS THERETO

WHEREAS Section 28 of the Ontario Heritage Act, R.S.O. 1980, chapter 337, provides that the Council of the Municipality may, by by-law, establish a local advisory committee to be known as City of Welland Heritage Advisory Committee to advise and assist the council on all matters relating to Parts IV and V of the said Ontario Heritage Act;

AND WHEREAS the Council of the City of Welland deems it advisable to establish such a committee and provide for the appointment of members thereto.

## NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF WELLAND ENACTS AS FOLLOWS:

- 1. A local advisory committee to be known as the City of Welland Heritage Advisory Committee is hereby established.
- 2. The local advisory committee shall consist of a minimum of five members. Members shall be appointed by Council.
- 3. Members shall be appointed for a four (4) year term concurrent with the term of Council.
- 4.1 All appointments of members to the City of Welland Heritage Advisory Committee made prior to or after this by-law shall be and be deemed for all purposes to be at the pleasure of Council.
- 4.2 Council may, at its pleasure, revoke and terminate any appointment.
- 4.3 Council may, at its pleasure, appoint a member to replace a member whose office or term of office has either expired, or been revoked and terminated, pursuant to the provisions of this by-law.
- 5. The City of Welland Heritage Advisory Committee shall, at its first meeting of each year, elect a Chairman from its membership.
- 6. The terms of reference of the City of Welland Heritage Advisory Committee shall be as follows:
  - (a) to establish criteria for the evaluation of properties of architectural and/or historical value or interest;
  - (b) to prepare and maintain a list of properties and areas worthy of conservation;
  - (c) to advise Council on means of conserving heritage properties and areas;
  - (d) to advise Council on current heritage conservation legislation and to assist Council in the preparation of municipal legislation to conserve heritage properties and areas;

- (e) to implement programs and activities to increase public awareness and knowledge of heritage conservation issues;
- (f) to advise and assist Council on all matters relating to Parts IV and V of the Ontario Heritage Act;
- (g) to advise and assist Council on any other matters relating to buildings and areas of architectural and/or historical significance;
- (h) to administer properties acquired by the municipality under Section 36 of the Ontario Heritage Act;
- (i) to prepare, before the 15<sup>th</sup> day of March each year, a report of the previous year's activities, a report of the previous year's expenditures and a projected budget for the succeeding year;
- (j) the local advisory committee shall meet as often as it deems necessary, but at least once each four months;
- (k) to receive and expend funds to carry out the aforesaid functions, subject to the approval of Council;
- (l) to consult with such persons, groups or organizations as it deems appropriate, such as, the Welland Historical Society and/or the Welland Heritage Council.
- 7. This by-law shall come into force and take effect on the date of its passing.
