99-99 WHEREAS the Welland Recreational Canal Corporation (WRCC) has stated that the majority of their operational budget is used for Canal Lands maintenance;

AND WHEREAS the WRCC has stated that the Welland International Flatwater Centre (WIFC) is self funding;

AND WHEREAS it may be financially and administratively advisable to separate maintenance activities from WIFC activities.

NOW THEREFORE BE IT RESOLVED THAT THE COUNCIL OF THE CITY OF WELLAND directs staff to prepare a detailed estimate of the cost for City workers, unionized and/or casual, to maintain the Canal Lands to the same current level as the WRCC.
