<u>04-47</u> WHEREAS public libraries provide residents with a community space where they can freely access a wide variety of information in both print and digital format;

AND WHEREAS municipal governments are key funders of public libraries, appoint public library boards and work in partnership with public library boards to deliver library services that are responsive to community needs; AND WHEREAS electronic books (e-books) are becoming an increasingly preferred medium for library users to access content and information;
