## **NOTICE OF MOTION**

Councillor Carl gave Notice of Motion to the following issue to be presented to Council at the February 17, 2015 Regular Council Meeting:

15-48 WHEREAS the City of Welland has many different Committees that play an important role in an advisory capacity to Council to ensure that the vast programming and services offered to the citizens of our community are fulfilled;

AND WHEREAS after months of advertising for interested citizens to fill the volunteer committee positions, some committees still have not received sufficient volunteer applications to fill the available positions rendering it impossible for those committees to operate fully and properly.

NOW THEREFORE BE IT RESOLVED THAT THE COUNCIL OF THE CITY OF WELLAND requests that the Clerk's Division review the current Advisory Committee structure and recommend ways that the many committees can be restructured and/or merged so that less volunteer positions need to be filled and the mandate of each committee can be achieved.

THAT THE COUNCIL OF THE CITY OF WELLAND directs staff to develop an Employee Performance Assessment Program for Senior Management at the City of Welland for consideration by City Council, and further THAT said program be implemented in 2015. Councillor Fokkens gave Notice of Motion to the following issue to be presented to Council at the February 17, 2015 Regular Council Meeting:

<u>15-51</u> WHEREAS Canadians will be celebrating Canada's 150<sup>th</sup> Anniversary of Confederation in 2017;

AND WHEREAS CBC/Radio-Canada, VIA Rail Canada and Community Foundations of Canada have joined forces to launch "2017 Starts Now" initiative connecting Canadians and building momentum for 2017 from the ground up;

AND WHEREAS Non-Profit (arts and culture, academic, youth, volunteer, newcomer and service club organizations), Public (government, aboriginal organizations, museums, libraries, local archives, parks and recreation departments) and Business Sectors (financial institutions, banks, Chambers of Commerce, advertising agencies and local small businesses) will be stakeholders in the celebrations;

AND WHEREAS the four simple components of the "2017 Starts Now" campaign are Introduction, Inspiration, Discussion and Conclusion.

NOW THEREFORE BE IT RESOLVED THAT THE COUNCIL OF THE CITY OF WELLAND creates a committee of dedicated citizens to meet regularly to collaborate on ideas and work together to make Canada's 2017 Anniversary of Confederation a reality.
