Mayor Campion gave Notice of Motion to the following issue to be presented to Council at the June 23, 2015 Special Council Meeting:

**99-99** WHEREAS the executive of the Welland Recreational Canal Corporation (WRCC) have and continue to make decisions outside the WRCC Board without express, procedural or policy authority;

AND WHEREAS the executive and executive director have attempted to change the governance By-laws without consultation or authorization from the sole voting member (City) despite warnings from the City and in contravention of its By-law (No. 1);

AND WHEREAS the WRCC has unreasonably delayed fulfilling requests for information and documents relative to the governance and operational review of the WRCC as directed by Council;

AND WHEREAS the WRCC has refused to provide details and contracts pertaining to the 2015 World Dragon Boat Championships despite several requests and the fact that the City is a funding partner;

AND WHEREAS WRCC has expended external grant funds allocated for a particular project on other items for cash flow purposes without the knowledge of the Board.

NOW THEREFORE BE IT RESOLVED THAT THE COUNCIL OF THE CITY OF WELLAND directs staff and the City's Legal Department to prepare the necessary documents, By-laws and motions that will enable the sole voting member (City) to replace the existing board of directors with an interim board at the July 21, 2015 Council Meeting. Said board to serve until the governance review is completed and a decision is made on a governance model. The new board to be comprised of the City representatives currently on the board and other members to be appointed at the July 21, 2015 Council Meeting.
