16-22 WHEREAS the City of Welland has been designated officially bilingual by the Province.

AND WHEREAS the French language and culture are an important fixture in the city, demonstrated by its 6 (six) francophone schools, health centre, employment center, 2 (two) financial institutions and a large catholic parish;

AND WHEREAS the City of Welland took the initiative to change the street signs to bilingual signs in French Town.

NOW THEREFORE BE IT RESOLVED THAT THE COUNCIL OF THE CITY OF WELLAND changes the stop signs to bilingual signs in the French Town area to match the existing street signs in this area. French Town being bordered by Main Street, Crowland Avenue, Hagar Street and the railway line to the west. This change would require some 23 signs. Bilingual stop signs can be found all over the north in the bilingual speaking communities. This would enhance the unique French section we have here in Welland. We should take advantage of this unique quality of our French Heritage.
