<u>16-51Z</u> Complete applications have been made by UPPER CANADA CONSULTANTS on behalf of VINMAR DEVELOPMENTS LTD. for approval of a Draft Plan of Subdivision and to rezone the lands at 250 South Pelham Road, 257 South Pelham Road and 545 Gaiser Road (northeast and southeast corners of South Pelham Road and Gaiser Road) from the existing RA and H-R3-X15 Zones to a Site Specific R3 Zone. The purpose of the Amendment is to permit the development of a Plan of Subdivision containing 12 lots for single-detached dwellings. The proposed Site Specific R3 Zone would permit a reduced front yard setback of 4.5 metres to the front face of the dwelling and 6.0 metres to the front face of the garage and permit an increased maximum lot coverage of 50%. The Official Plan designation is LOW DENSITY RESIDENTIAL. (File No. 2015-10 and File No. 26T-14-15003.

R. Di Felice confirmed that the statutory requirements for public hearing had been met, summarized the purpose of the hearing and reviewed the Planning Division Report.
