- 1. That the Owner enter into a Subdivision Agreement with the City of Welland to be registered on Title;
- 2. That no grading or construction work shall commence on site until such time as the Subdivision Agreement has been entered into, all financial security is in place and the Plan and all documentation has been registered on Title;
- 3. That all necessary Easements required for utility and servicing purposes be granted to the appropriate Authority free of all encumbrances;
- 4. That Blocks 34, 35, 36 and 37 being 0.3 metre Reserves, be transferred to the City of Welland free of all encumbrances for access control purposes;
- 5. That the City of Welland lay out and establish Block 57, Plan 59M-165 and Block 20, Plan 59M-288 as part of North Valley Drive;
- 6. That the Owner shall pay to the City of Welland, upon execution of the Subdivider's Agreement, \$300.00 per dwelling unit for the installation of trees within the road allowance by City forces;
- 7. That the Owner, and any subsequent Owner of any of the Lots, agrees to pay 5% Cash-in-Lieu of Parkland Dedication in accordance with By-law 2014-101 and the City's Policy. The current Owner shall establish the value of land for each Lot to the satisfaction of the City prior to the issuance of the first Building Permit. The values shall be determined by a qualified Appraiser in accordance with City Policy as of the day before the day the first Building Permit is issued for the development. This requirement and Policy shall be referenced in the Special Conditions of the Subdivider's Agreement and the Restrictive Covenants registered on Title;

- 8. The Owner shall provide a Geotechnical Subsurface Investigation Study, prepared by a qualified Geotechnical firm, to the City which must make recommendations on the use of the site for the construction of houses/buildings;
- 9. The Owner shall have the project Engineer provide calculations which show that there is adequate downstream capacity to accept the new proposed development sanitary flow;
- 10. The Owner shall have the project Engineer provide confirmation/calculations which show that there is adequate water pressure and fire flow capacities for the new development when it is connected to existing watermain(s);
- 11. With respect to the proposed expansion of the Storm Water Management (SWM) facility at the end of Mason Court, the Owner shall provide the City with an updated SWM Report to confirm adequate capacity will exist for stormwater storage during ultimate Conditions;
- 12. That the Owner acknowledge promptly to the Regional Planning Department that the Draft Approval of this Subdivision does not include a commitment of servicing allocation by the Regional Municipality of Niagara. Servicing allocation will be assigned instead at the time of Final Approval of this Subdivision for registration purposes;
- 13. That the following warning clause(s) be included in the Subdivider's Agreement and inserted in all Agreements of Purchase and Sale or Lease for Lots 1, 2, 30, 31, 32, and 33: "The lands in the Plan of Subdivision may be exposed to noise, odour, dust, lights or vibrations from nearby agricultural operations that may interfere with some activities of the owners/tenants who occupy these lands";
- 14. That the following warning clause(s) be included in the Subdivider's Agreement and inserted in all Agreements of Purchase and Sale or Lease for Lots 1, 2, 30, 31, 32, and 33: "The lands in the Plan of Subdivision may be exposed to noise, odour, dust, lights or vibrations from nearby agricultural operations that may interfere with some activities of the owners/tenants who occupy these lands";
- 15. That the Owner provides a written acknowledgement to the Niagara Region Planning and Development Services Department stating that Draft Approval of this subdivision does not include a commitment of servicing allocation by the Niagara Region as servicing allocation will not be assigned until the Plan is registered and that any pre-servicing will be at the sole risk and responsibility of the Owner:
- 16. That the Owner shall provide a written undertaking to the Regional Niagara Planning and Development Services Department stating that all Offers and Agreements of Purchase and Sale or Lease, which may be negotiated prior to registration of the subdivision, shall contain a clause indicating that servicing allocation of this subdivision will not be assigned until the Plan is registered, and a similar clause be inserted in the Subdivider's Agreement between the Owner and the City Of Welland;
- 17. That prior to final approval for registration of this Plan of Subdivision, the Owner shall obtain Ministry of the Environment and Climate Change Compliance Approval under the Transfer of Review Program;
- 18. That the Owner submit to the Niagara Peninsula Conservation Authority for review and approval detailed grading, storm servicing, stormwater management and construction sediment control plans;
- 19. That Condition "18" above be incorporated into the Subdivider's Agreement between the Owner and the City of Welland to the satisfaction of the NPCA. The City of Welland shall circulate the draft Subdivider's Agreement to the NPCA for its review and approval;
- 20. That prior to the granting of Approval for the Final Plan, City of Welland Planning Division will require written notice from the following upon their respective Conditions having been met satisfactorily:
  - Regional Niagara Planning and Development Services for Conditions 12, 13, 14, 15, 16 and 17; Niagara Peninsula Conservation Authority for Conditions 18 and 19.
- 21. That if Final Approval is not given to this Plan within three (3) years of the approval date and no extensions have been given, Draft Approval shall lapse.
