THAT THE COUNCIL OF THE CITY OF WELLAND approves the request by Mr. lannetti to provide an exemption to the current Policy for 5% Cash-In-Lieu of Parkland Dedication for the Vanier Estates Subdivision; and further

THAT Welland City Council directs staff to prepare an 'area specific' By-law to require the 5% Cash-In-Lieu of Parkland Dedication to be calculated as of the day before Draft Plan Approval for the Vanier Estates Subdivision; and further

THAT Welland City Council amends Condition 7 of the Draft Plan approval for the Vanier Estates Subdivision (File 26T-14-15002) to state that 5% Cash-In-Lieu of Parkland Dedication will be calculated as of the day before Draft Approval.

THAT THE COUNCIL OF THE CITY OF WELLAND not exempt Habitat for Humanity Niagara (HFHN) from the requirement to pay Building Permit fees for builds in Welland; and further

THAT Welland City Council directs staff to prepare a By-law to authorize an Agreement with Habitat for Humanity Niagara to provide exemptions for the payment of Development Charges in accordance with the Development Charges By-law; and further

THAT Welland City Council not provide, nor pay for, municipal servicing for private lands acquired by Habitat for Humanity Niagara; and further

THAT Welland City Council not exempt Habitat for Humanity Niagara from the requirement to pay Planning Application fees for builds in Welland, or alternately, Council will consider Permissive Grants in lieu of such fees on a case-by-case basis upon application; and further

THAT Welland City Council not consider refunds to Habitat for Humanity Niagara for fees/costs paid for past builds with the exception of City of Welland Development Charges in accordance with an Agreement with Habitat for Humanity Niagara; and further

THAT the request by Habitat for Humanity Niagara for the City of Welland to participate at build days be at the pleasure of Council; and further

THAT Welland City Council appoints the Staff person responsible for Property Sales as the main contact with Habitat for Humanity Niagara; and further

THAT Welland City Council considers transferring one (1) at a value of \$10,000 to Habitat for Humanity Niagara with HFHN entering into an Agreement with the City indicating Habitat's responsibility including paying for any Building Permit related fees; and further

THAT Welland City Council provides an exemption to Habitat for Humanity Niagara to the payment of Cash-in-Lieu of Parkland Dedication Policy for the build on a new lot; and further

THAT the request by Habitat for Humanity Niagara for the City of Welland to take a leadership role in creating a Steering Committee be at the pleasure of Council.
