F&ES-2017-01 Fire Chief, Fire and Emergency Services, B. Kennedy – Fire and Emergency Services Facilities Update. Ref. No. 17-15

Brian Kennedy provided a presentation to the committee members regarding a three (3) station model for City of Welland Fire and Emergency Services. Staff discussed the master plan, city and department growth, development and training. The committee raised questions regarding funding opportunities and assistance from other levels of government, additional equipment with the three (3) model plan, and maintenance of current fire halls. Staff advised that a number of funding opportunities will be investigated, additional equipment is not required for the three (3) station model, and discussed maintenance of the current fire halls.
