# CONCLUSION OF JUNE 6, 2017 LEGISLATED PUBLIC HEARING PURSUANT TO THE PLANNING ACT

Councillor Van Vliet presided as Chair of the Public Hearing:

<u>13-117</u> The purpose of the new Comprehensive Zoning By-law is to provide a set of updated and current regulations that conform to the City's Official Plan and provincial legislation. The proposed Comprehensive Zoning By-law includes a 'Schedule' of maps identifying zones for all properties in the City and a 'Schedule' that incorporates certain site specific development parameters. With the passing of the new Zoning By-law, the existing Zoning By-law 2667 and 1538 (Crowland) will be repealed.

G. Munday confirmed that the statutory requirements for public hearing had been met, summarized the purpose of the hearing and reviewed the Planning Division Report.
