#### 4.4 LEGISLATED PUBLIC HEARINGS PURSUANT TO THE PLANNING ACT

18-39 A complete application for Zoning By-law Amendment has been submitted by Upper Canada Consultants on behalf of Vinmar Developments Ltd. for lands legally described as Part of Lot 1, Concession 12, former Township of Pelham, City of Welland, municipally known as 370 Murdock Road, to rezone the lands from RL1 - Residential Low Density 1 and RM - Multiple Residential to Special Exception RL1 and Special Exception RM. The Special Exceptions are requested to allow: a reduced lot area of 360 square metres, increased lot coverage of 55%, and allow rear yard decks and porches (opened or roofed) to extend 4.5 metres into the required rear yard decks and porches (opened or roofed) to extend 4.5 metres into the required rear yard in the RM Zone. These requests have been made to allow for the development of the property with a Plan of Subdivision containing single detached and townhouse dwellings.
