WHEREAS the City has an obligation to provide/distribute safe drinking water to residents;
AND WHEREAS it is necessary to bleed dead end water pipes to ensure chlorination levels are maintained;

AND WHEREAS this procedure adds to our unbilled water consumption which increases cost. NOW THEREFORE BE IT RESOLVED THAT THE COUNCIL OF THE CITY OF WELLAND directs staff to identify other means of ensuring water quality and chlorination levels and their associated costs so Council can consider these alternatives during budget discussions.
