#### **COMMENTS AND ANALYSIS:**

Council approved the Interim Tax Levy Bylaw # 2021-2 on January 12, 2021, as per Section 317 of *The Municipal Act, 2001.* Staff is now seeking approval for the 2021 Final Tax Levy.

Beginning with the 2022 Tax Year, staff is seeking approval to move the tax due dates to the last business day of the previous month as opposed to the first business day of the month. This would mean that the Residential due dates in 2022 would be February 28, April 29, June 30, and August 31. The rationale for changing the due dates is that with all institutions going on direct deposit and more and more people going on our PAP, this would simplify the banking process, and additionally it allows for the prompt, effective, and efficient collection of taxes.

#### **FINANCIAL CONSIDERATION:**

#### **SUMMARY AND CONCLUSION:**

#### **RECOMMENDATION:**

THAT THE COUNCIL OF THE CITY OF WELLAND approves the purchase of one (1) complete backhoe loader unit from Brandt Tractor Ltd. being the lowest priced offering that met specifications; and further;

THAT Welland City Council directs the City Clerk to prepare all necessary and appropriate Bylaws to enter into a purchase contract with Brandt Tractor Ltd.

#### **ORIGIN AND BACKGROUND:**

The purchase of one (1) backhoe loader unit received Council approval within the 2021 Water Fleet Capital Budget. This well-used unit utilized by the water department operators has accumulated a high amount of service hours and is scheduled for replacement.

#### **COMMENTS AND ANALYSIS:**

The City of Welland cooperatively bid this opportunity with the Township of West Lincoln and Niagara Region in effort to leverage pricing for the mutual needs. There were discount incentives available if like units were purchased, however each agency is free to decide on which offering was best for their need.

Cooperative bid documents for the replacement units were prepared as soon as individual agency specifications were available so qualified vendors may supply a bid response.

#### FINANCIAL CONSIDERATION:

A Request for Tender document was advertised on the City's Biddingo site and closed April 29, 2021. In total, there were three submissions, but only two of them met specifications for the City

of Welland requirements. Pricing below does not show discount incentive, as the outcome of the other agencies is unknown at the date this report was prepared.

Unit will be funded by the Fleet Capital Project: 10-910-21301

The replacement unit will offer increased versatility as additional attachments shall be purchased to assist with digging and material handling functionality. This means the unit will offer more productivity during daily work functions.

#### OTHER DEPARTMENT IMPLICATIONS:

The specifications have been reviewed and approved by the shop fleet foreman and management staff at the Public Works facility. The other participating agencies will conduct their own internal review of specifications and make their independent equipment recommendations and subsequent award.

#### **SUMMARY AND CONCLUSION:**

THAT Welland City Council approves the purchase of the new backhoe from Brandt Tractor Ltd. offering competitive pricing that is compliant with the provided bid specifications.

#### **RECOMMENDATIONS:**

THAT THE COUNCIL OF THE CITY OF WELLAND renews an agreement with the Niagara SPCA and Humane Society (SPCA) for a period of five years commencing January 1, 2022 and expiring December 31, 2026; and further

THAT Welland City Council directs the City Clerk to prepare all necessary and appropriate by-laws to enter into the updated Agreement with the Niagara SPCA and Humane Society.

## **ORIGIN AND BACKGROUND:**

The current Agreement with the Niagara SPCA and Humane Society expires December 31, 2021.

#### **COMMENTS AND ANALYSIS:**

For over fifty years, the Niagara SPCA and Humane Society (SPCA) has provided a range of services related to animal control and care in Welland and the surrounding areas. With respect to the City, the following is a brief summary of the current contractual services:

- Administration Services (licensing, admin costs, serving as "Poundkeeper");
- Inspection Services (general patrols, responding to complaints, inspections);

- Enforcement Services (conduct investigations, achieve compliance, expeditiously respond to complaints, feed and care of animals impounded)
- Prosecution and Court Services
- Other Services including Impoundment Services

Over the many years of service delivery to municipalities, the SPCA has also provided the following:

- Public education on the responsibilities of pet ownership and animal care;
- Dedicated Vet Technician and Veterinarian;
- Various off site adoption events;
- Vet clinic with low cost spay/neuter services and full veterinarian care.

Staff have been very satisfied with the cervices provided by the SPCA. The proposed contract renewal includes no cost increases except for the Consumer Price Index (CPI). The CPI yearly increase will cover the rising cost of wages, fuel and operating expenses over the length of the contract

#### SCHEDULING:

This Agreement would commence January 1, 2022 and expire December 31, 2026.

#### **FINANCIAL CONSIDERATION:**

The cost of this new contract will result in the following funds added to the Bylaws Operating Budget 540500 20-525-000 as followed:

#### **SUMMARY AND CONCLUSION:**

The current Agreement with the SPCA expires December 31, 2021. The SPCA has provided a range of contractual services to the City of Welland as outlined in this report. Staff recommends the renewal of the Agreement, for an additional five-year term, which will then expire December 31, 2026.

#### **ORIGIN AND BACKGROUND:**

On this occasion, **SCHEDULE** "I" will be affected.

#### SCHEDULE "I" – Municipal/ Private Property

An amendment is required to include 60 King Street and 547 Thorold Road to the City of Welland Municipal/ Private Property Schedule of By-law 89-2000.

This will allow Parking Enforcement Officers to enter onto private lands at the request of the property owner to issue a penalty notice and/ or remove unauthorized vehicles.

#### **COMMENTS AND ANALYSIS:**

The proposed amendments to the Traffic and Parking By-law 89-2000 are necessary to define the traffic and parking regulations on Municipal and Private Property within the City of Welland.

#### FINANCIAL CONSIDERATION:

As properties are added to the Municipal/ Private Property Schedule a slight increase to parking ticket revenue can be expected.

#### OTHER DEPARTMENT IMPLICATIONS:

Legal Services and the Clerks Department would be required to update the Bylaws with the changes noted in this report.

#### **SUMMARY AND CONCLUSION:**

The addition to the Municipal/ Private Property schedule is at the request of the property owner. Private property owners that are experiencing difficulties with illegally parked vehicles on their property can join the Traffic and Parking By-law as a solution. Once added to the by-law, Parking Enforcement Officers will be able to enter onto the private lands at the request of the property owner to enforce parking regulations.

Staff recommends the modifications as outlined in this report.

#### **RECOMMENDATION:**

THAT THE COUNCIL OF THE CITY OF WELLAND received for information report CLK-2021-16: Council Composition – Eight (8) Wards and Eight (8) Councillors for the 2022 Municipal Election; and further

THAT Welland City Council approves increasing the number of wards to eight (8) and reducing the number of councillors to eight (8).

#### **ORIGIN AND BACKGROUND:**

On June 16, 2020 council approved a motion requesting staff prepare a report regarding reducing the number of councillors to eight (8) and increasing the number of wards to eight (8) for the 2022 Municipal Election.

#### **COMMENTS AND ANALYSIS:**

On September 8, 2020 staff prepared a report for council consideration in relation to the ward and council boundaries. The purpose of the report was to identify the process for conducting a ward boundary review. This information was communicated to council to advise them of potential costs for a ward boundary review to be conducted.

Following the discussion at the September 8, 2020 meeting, council approved a motion directing staff to commence a public engagement survey to determine the optimal number of councillors and wards for Welland.

On October 21, 2020 a Welland Ward & Councillor survey was launched. On March 2, 2021, staff prepared a report which present the results of the Welland Ward and Council Review – Public Engagement Survey. CLK-2021-04 is included in "Appendix I".

Following the discussion at the March 2, 2021 Welland City Council meeting, council directed staff proceed with preparing a report for council consideration regarding increasing the number of wards to eight (8) and reducing the number of councillors to eight (8).

#### Increasing the number of wards

If council approves proceeding with increasing the number of wards to eight (8), the decision would need to be made by December 31, 2021. As per the *Municipal Act, 2001*, section 222 (8) states:

A by-law of a municipality described in this section comes into force on the day the new council of the municipality is organized following,

- (a) the first regular election after the by-law is passed if the by-law is passed before January 1 in the year of the regular election and,
  - (i) no notices of appeal are filed,
  - (ii) notices of appeal are filed and are all withdrawn before January 1 in the year of the election, or
  - (iii) notices of appeal are filed and the Tribunal issues an order to affirm or amend the by-law before January 1 in the year of the election; or

The proposed timeline to redivide and increase the number of wards would be as follows:

- <u>June 8, 2021</u> a staff report will be included on the General Committee meeting agenda which will provide recommendations for potential ward boundaries for eight (8) wards.
- <u>June 16, 2021</u> Staff to present a by-law for council consideration regarding the redividing and increase of the ward boundaries.
- <u>July 1, 2021</u> The deadline for the municipality to give notice of the passing of the by-law to the public specifying the last date for filing a notice of appeal.
- <u>July 30, 2021</u> The deadline for the Minister or any other persons or agency to appeal to the Local Planning Appeal Tribunal (LPAT) by filing a notice of appeal with the municipality setting out the objections to the by-law and the reasons in support of the objection.
- <u>August 13, 2021</u> The deadline for the municipality to forward any notices of appeal to the Tribunal.

Following the August 13, 2021 deadline, if appeals are received they will be forwarded to the Tribunal. Staff cannot confirm on the timeline as to when the municipality would receive a decision by the Tribunal.

The City of Welland is expecting significant growth over the next 10 years. Some of that growth will be due to the Dain East Subdivision, Dain West Subdivision, Fusion Homes Subdivision, Canal Trail Subdivision; Hunter's Point Subdivision, South Village, North-West Urban Expansion Area, the Northern Reach, new accessory dwelling units in existing residential areas and a range of proposed medium and high density infill developments across the City. The expected growth in these areas will result in over 10,000 new residents based on known developments, building permit statistics and the City Population forecast to 2031.

Included in "Appendix II" of this staff report is an example of eight (8) ward boundaries for the City of Welland. The purpose of the example is to provide details regarding potential balancing the population per ward. The information provided below is based on 2016 population with assumed growth within the municipality in the next ten (10) years. As outlined in "Appendix II" the breakdown is as follows:

# Reducing the number of councillors

The deadline for the municipal council to approve a by-law to amend the composition of council is December 31, 2021.

As per the Municipal Act, 2001, Section 217 (1):

## Composition of council of local municipality

**217** (1) Without limiting sections 9, 10 and 11, those sections authorize a local municipality to change the composition of its council subject to the following rules:

- 1. There shall be a minimum of five members, one of whom shall be the head of council.
- 2. The members of council shall be elected in accordance with the Municipal Elections Act, 1996.
- 3. The head of council shall be elected by general vote.
- 4. The members, other than the head of council, shall be elected by general vote or wards or by any combination of general vote and wards.
- 5. The representation of a local municipality on the council of an upper-tier municipality shall not be affected by the by-law of the local municipality under this section. 2001, c. 25, s. 217 (1); 2006, c. 32, Sched. A, s. 92 (1).

Members of council raised concerns regarding the impact on the committees of council and council representation. If there was a reduction of the number of councillors it is staffs recommendation that a review of the membership for the advisory committees be conducted and presented to council for their consideration.

#### **ORIGIN AND BACKGROUND:**

On June 16, 2020, council approved a motion requesting staff to prepare a report regarding reducing the number of councillors to eight (8) and increasing the number of wards to eight (8) for the 2022 municipal election. In addition, council requested the process include an engagement survey for residents, business owners and community partners.

On September 8, 2020, report CLK-2020-19: Council Composition & Ward Boundaries was presented to council. The report identified information regarding council composition and the process for conducting a ward boundary review. Following the discussion on the matter, council approved a motion directing staff to commence a public engagement process to determine the optimal number of councillors and wards for Welland.

#### **COMMENTS AND ANALYSIS:**

On October 21, 2020, the Welland Wards & Councillors Review survey was launched on YourChannel. In addition to the online survey, participants had the option to call in their input related to the survey. The engagement survey ended on November 30, 2020.

Residents, business owners and community partners were encouraged to participate in the survey and attend in the public meetings.



Whereas the Municipal Council of the Town of Fort Erie passed a resolution on October 21st, 2019 identifying that 1,100 private water wells were in operation in the Town of Fort Erie, of which 75% were used for domestic purposes including human and livestock consumption, and

Whereas the Municipal Council of the Town of Fort Erie further identified in that resolution that Council requires the protection of water in the aquifer supplying water to those wells from contamination as the result of any remediation of Pit One owned by the Port Colborne Quarries in the City of Port Colborne, and further

Whereas Report No. PDS-23-2021, approved by Council on March 22, 2021, identified that while the Niagara Peninsula Conservation Authority, The Regional Municipality of Niagara and Local Area Municipalities work together to protect source water, these plans do not generally apply to private servicing, and

Whereas Report No. PDS-23-2021 further identified efforts undertaken by the Town of Fort Erie through available provincial planning policy, regulation and legislation to protect source water within the Town of Fort Erie without any explicit ability to designate source water protection for private services, and

Whereas on July 28, 2010, through Resolution 64/292, the United Nations General Assembly explicitly recognized the human right to water and sanitation and acknowledged that clean drinking water and sanitation are essential to the realization of all human rights, and

Whereas it would be desirable to ensure that those in our community who rely on wells and other private servicing for clean drinking water are afforded the same source water protection as municipal drinking water systems;

Re: Resolution - Federal Government Cannabis Consultation

Please be advised that, at its meeting of April 26, 2021, the Council of The Corporation of the City of Port Colborne resolved as follows:

**THAT WHEREAS** the Government of Canada introduced Bill C-45 (the Cannabis Act) to create the foundation for a comprehensive national framework to provide restricted access to regulated cannabis, and to control its production, distribution, sale, importation, exportation, and possession;

**AND WHEREAS** unlicensed and unmonitored cannabis grow operations have increasingly become a problem in communities in Ontario as well as across the Country;

AND WHEREAS these operations are allowed to establish with little or no consultation with the local community and municipalities are often only made aware of their existence after conflicts arise with neighboring land owners;

**AND WHEREAS** there is no direct communication or dedicated effort to provide a communication channel between Municipal government staff or Police Agencies for dealing with Health Canada Registrations and Licenses;

**AND WHEREAS** the City of Port Colborne has not been consulted by Health Canada prior to the issuance of licenses for properties not in compliance with municipal zoning by-laws;

**AND WHEREAS** loopholes in existing Federal legislation allow these large scale grow op's to establish and operate without any of the regulations or protocols that licensed and monitored operations need to adhere to;

**AND WHEREAS** the police have not been given lawful authority to lay charges under the Cannabis Act to appropriately respond to violations of Health Canada Registrations and Licenses;

**NOW THEREFORE BE IT RESOLVED THAT** the City of Port Colborne urges the Federal Government and Health Canada to amend the legislation under which these facilities operate to ensure the safety and rights of the local communities in which they are situated are respected;

Limit the authorization to produce cannabis plants for personal medicinal use to the maximum daily quantity as prescribed by a professional medical practitioner to members of the immediate family living in the same residence;

Prohibit the ability for an individual to designate the growing and processing of medical cannabis plants and cannabis products by another individual on their behalf unless that individual is a member of the immediate family and resides in the same residence:

That medical marijuana be added to the approved drug list so that it be a covered cost under OHIP:

Issue one license to the property where the growing of medical cannabis for personal purposes is to be permitted;

Require Federal Licenses and Registrations for Designated Growers to conform with local zoning and control by-laws. Make it mandatory as part of the registration that the applicant provide a signed and dated declaration from the local municipality providing consent to the production and quantity of cannabis plants and products prior to approval of a licence to grow medical cannabis plants for personal consumption;

Ensure local authorities are provided with notification of any licence issuance, amendment, suspension, reinstatement or revocation within their region;

Provide dedicated communication with local governments and Police services;

Provide lawful authority to Police agencies to lay charges when registered or licences operations grow in excess of their registration or licence through Health Canada; and,

Provide enforcement support and guidance to local municipalities for dealing with land use complaints relating to Cannabis.

**AND FURTHER BE IT RESOLVED THAT** the City of Port Colborne forward this motion to the following;

Re: Town of Lincoln Council Resolution regarding Climate Change Adaptation Plan and Crisis

Please be advised that Council for the Corporation of the Town of Lincoln at its Special Council Meeting held on April 19, 2021 passed the following motion:

Moved by: Councillor J.D. Pachereva; Seconded by: Councillor Greg Reimer;

WHEREAS climate change is already having an impact on global economies, communities, and the built and natural environments; and

WHEREAS climate change remains the most significant global threat to the quality of life and security – for current and future generations; and

WHEREAS the most recent report by the UN Intergovernmental Panel on Climate Change (IPCC) has indicated that within 10 years, to keep the global average temperature increase to 1.5 degree C and maintain a climate compatible with human civilization, there must be a reduction in carbon emissions of about 45% from 2010 levels, reaching net zero carbon emissions by 2050; and

WHEREAS bold and collective action at global, national and community levels is required to effect change, build resilience, mitigate future threats and ensure a prosperous future for generations to come; and

WHEREAS the Town of Lincoln understands that climate action and a low carbon transition also represents an opportunity for economic stimulation and job development opportunities in a new low carbon economy; and

WHEREAS on July 22, 2019 Council of the Town of Lincoln passed a resolution supporting the development of a Corporate Climate Adaptation Plan; and

WHEREAS on March 29, 2021 Council adopted the Corporate Climate Change Adaptation Plan.



THEREFORE, BE IT RESOLVED that the Council of the Town of Lincoln immediately declare a Climate Crisis and for the purposes of recognizing the urgent need to take action to mitigate the effects of climate change and to deepen the Town's commitment to protecting its economy, ecosystems, and community from climate change; and

- THAT the Town of Lincoln, officially declare a climate crisis for the purposes
  of joining a national and international movement consisting of a growing list
  of 509 municipalities in Canada and 1918 municipalities in 34 countries; and
- 2. THAT our CAO and staff be directed to work with other Local Area Municipalities and across Ontario to make our climate change initiatives permanent; and
- 3. THAT Council acknowledges that the climate change crisis poses a real serious threat and comprehensive changes and investments will be required to adapt to the impacts of climate change, mitigate climate risk, and prepare for our climate future.




