WHEREAS, the increase of homelessness in Welland and the severe weather changes have forced some residents to sleep in areas without shelter and

WHEREAS, the number of available emergency beds in Welland do not adequately provide for the residents of Welland that are living on the streets and

WHEREAS, the homeless in Welland are adverse to being transported to St Catharines shelters

WHEREAS, the City of Welland subscribes to be a passionate and responsible public body to the residents and

WHEREAS, Holy Trinity Church, the Hope Center and Beyond the Streets have provided letters of support for volunteers and the NRPS CORE Team has agreed that this would be beneficial for the City of Welland for both Welland residents and the NRPS and

WHEREAS, the Hope Center has agreed to seek the hiring of a professional Social Worker for the period of February and March 2023

NOW THEREFORE IT BE RESOLVED THAT THE COUNCIL OF THE CITY OF WELLAND, as a pilot project, will offer the Welland Tennis Club as a temporary overnight emergency shelter for Welland residents on Thursdays, Fridays and Saturday nights 7pm to 7am for the period of February and March 2023 - contingent on it being staffed overnight by a Social Worker; and further

THAT the Council of the City of Welland will provide funding of \$9,000 to the Hope Center for the hiring of a professional social worker to be funded by the Capital Reserve fund; and further

THAT this pilot project will be reviewed in April 2023 and staff will present a report to Council for opening an overnight emergency shelter for the 2023/2024 winter.
